In the said First Schedule after "Mahatma Jyotiba Phule Rohilkhand University, Bareilly" and under the heading 'Recognized Medical Qualification' [Hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration" [Hereinafter referred to as column (3)], the following shall be inserted, namely:-

Bachelor of Medicine and Bachelor of Surgery

M.B.B.S.

This shall be a recognized medical qualification when granted by Mahatma Jyotiba Phule Rohilkhand University, Bareilly in respect of students being trained at Rajshree Medical Research Institute, Bareilly with annual intake of 150 MBBS students on or after February, 2019.

- Note: 1. The recognition so granted to an undergraduate courses for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
 - 2. The procedure for 'Renewal' of recognition shall be same as applicable for the award for recognition.
 - 3. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned undergraduate Course.
